LETTER OF SUPPORT – BBRF APPLICATION

On behalf of Regional Development Australia Goldfields-Esperance (RDAGE) I am pleased to provide a letter of support to the Esperance Bay Yacht Club (Club) for their application to Round 5 of the Building Better Regions Fund for the redevelopment of the Esperance Bay Marina.

RDAGE is one of 52 committees representing regional areas across Australia and is funded by the Australian Government and administered by the Department of Infrastructure, Transport, Regional Development and Communications. RDA Committees have an active and facilitative role in their communities and a clear focus on growing strong and confident regional economies that harness their competitive advantages, seize on opportunity and attract investment.

The recreational boating industry in Esperance has been held back as the existing facilities have been at full capacity for years, with wait lists. The marina's 40-year old pens are in dire need of replacement and expansion to house more locally owned vessels, both private and commercial.

The Club is applying to the Federal Building Better Regions Funds to remove the existing 34 pens and replace them with a modern 52 pen floating marina, including a pen for cruise ship tender access which will be available to emergency services. A marine engineer has been appointed to design and manage the construction of the new marina. This has been substantially funded by donations from members to date with the balance being funded by a self-supporting loan of the Club.

Economic modelling studies have been completed which predict nearly \$5 million will be injected into the local economy as well as the creation of jobs during the construction phase. Post construction, this project will stimulate approximately \$21.75 million into the local economy over the 50-year life span of the marina.

The social benefits include support and promotion of the boating and fishing community, the tourism industry, and improved access for emergency services. More people will have access to the ocean amenity and our stunning Recherche Archipelago.

This infrastructure project will create an important intergenerational asset for the broader Esperance Goldfields Community.



Re: Esperance Bay Marina project

I write to endorse the endeavours of Esperance Bay Yacht Club to redevelop the Esperance Bay Marina with assistance from the Commonwealth's Building Better Regions Fund (BBRF).

It is my understanding that Esperance's recreational boating industry has been held back because the existing marina and State-owned recreational pens at Bandy Creek have long been at full capacity.

I am also advised that the 34 existing boat pens need to be replaced, and the project would allow more commercial and private vessels to be accommodated.

So, my congratulations go to the club for having raised the funds for designing a new 52-pen marina.

I understand BBRF support is being sought to help remove the existing pens and replace them with a new marina. The balance of funds would be raised by a self-supporting loan to the club.

One part of the project with potential to assist economic development and marine safety is a new pen for cruise ship tenders that could also be used by emergency boats and so decrease response times.

I understand the construction phase would see \$5 million flow into the Esperance economy, while after construction \$21.75 million of local economic activity would ensue. With regard to tourism, I am advised that more visitors would be able to access the magnificent Recherche Archipelago.

I believe this important infrastructure project would create an intergenerational economic and social asset for Esperance and the Goldfields region more generally.

LETTER OF SUPPORT - ESPERANCE BAY MARINA REDEVELOPMENT

It is my pleasure to provide this letter supporting the Esperance Bay Yacht Club's (EBYC) application to the Federal Building Better Regions Fund to redevelop the Esperance Bay Marina.

The EBYC has a long history as one of the strongest sporting clubs in Esperance. EBYC members have proven themselves as committed individuals, passionate to supporting and growing the club.

It is my understanding that the EBYC constructed a breakwater and 34 holding pens to house members' vessels approximately 40 years ago. The pens are now in need of replacement with strong community demand for at least an additional 18 pens.

At present, Bandy Creek Boat Harbour is the only other facility in the Esperance region which has pens available to house recreational and professional boats. The facility is operated and maintained by the Western Australian Department of Transport and has been at full capacity for a number of years, with substantial waiting lists. The Department has no plans to expand the facility.

On this basis, I believe that there is obvious merit in the EBYC proposal to replace the existing 34 pens with a 52 vessel capacity floating style marina, as it will not only accommodate those vessels on the waiting list at the Bandy Creek facility, but provide additional safe mooring capacity for emergency services vessels and cruise ship tenders. Importantly, the proposal by the EBYC to utilise floating marina technology will also provide the added benefit of improving access for people with limited mobility or a disability. I also acknowledge the EBYC's commitment to the community in continuing to provide access to the breakwater for members of the public for recreational purposes.

This is a significant construction project that will provide an immediate boost to the local economy during the construction phase. Ongoing, the new marina will have the capacity to host more passing craft and cruise ship tenders, resulting in an increase in visitor numbers, and consequential longer term economic benefit to the local community.

As such, I strongly support the EBYC's application to secure funding through the Commonwealth Government's Building Better Regions Fund. I believe the project has significant economic and wider social benefits for the Esperance Goldfields community.

LETTER OF SUPPORT - ESPERANCE BAY YACHT CLUB

I write in support of endeavours of the Esperance Bay Yacht Club to redevelop the Esperance Bay Marina.

The recreational boating industry in Esperance has shown strong growth with the Esperance Bay Marina and the Department of Transport's recreational pens at Bandy Creek being at full capacity, with both now having waiting lists.

The marina is within Southern Ports. The Esperance Bay Yacht Club built the rock wall, the jetty and pens 40 years ago with volunteer labour. The rock wall is sound, but the pens are in dire need of replacement and the ability to house more locally owned vessels, private and commercial.

EBYC has appointed MP Rogers, a marine engineer to design and manage the construction of a new floating pen marina. This has been substantially funded by donations from members to date.

The club is now applying to the Federal Building Better Regions Funds to remove the existing 34 pens and replace them with a modern floating 52-pen marina. I understand that the balance of the project will be funded by a self-supporting loan by EBYC. Public access to the breakwater for fishing, recreation and tourism will continue. The project also includes a pen for cruise ship tender access that will also be available to emergency services.

EBYC are working with the Southern Ports Authority, the State Government, and the Shire to build a public land backed wharf in front of the Taylor Street Quarters to improve facilities for local and visiting boats, tourism and emergency services.





Economic modelling studies have been completed which predict nearly \$5 million will be injected into the local economy, with the creation of seven new positions during the construction phase. Post construction, this project will stimulate approximately \$21.75 million into the local economy over the 50 year lifespan of the marina.

The social benefits include support and promotion of the boating and fishing community, the tourism industry, and improved access for emergency services. More people will have access to the ocean amenity and our stunning Recherche Archipelago.

We see this infrastructure project as creating an important intergenerational asset for the broader Esperance Goldfields Community.

I am delighted to provide a letter supporting the Esperance Bay Yacht Club (EBYC) application to the Federal Building Better Regions Funds to enable redevelopment of the Esperance Bay Marina.

The club is one made up of individuals who are committed to encouraging a thriving community, members who see a great future for the region and who are keen to play a role in ensuring that it continues to be a wonderful place for people to live and work.

I understand that the existing 34 pen marina, built by the EBYC four decades ago, is not only in need of replacement due to its condition, but is also too small to meet current demand.

While the Bandy Creek Boat Harbour can house recreational and professional boats, the Department of Transport operated facility has been at full capacity for years. Waiting lists indicate the level of demand for mooring sites. I have been advised that the department has no plans to expand the Bandy Creek facility.

Dear David,

The Esperance Goldfields Surf Life Saving Club (EGSLSC) wishes to provide their utmost support and endorsement for the Esperance Bay Marina Redevelopment. We have been briefed by the EBYC and believe the services being offered to the EGSLSC will enhance its ability to carry out its Emergency Response Services.

EGSLSC carries out an important role within the Esperance community. We provide beach patrol services under agreement with the Shire of Esperance from December to March each year.

In addition to this service EGSLSC operate an Emergency Response Service. This is a service that may be called upon at any time to operate in potentially life threatening situations, often in extreme and hazardous conditions. Two dedicated Jet Skis are based in Esperance and provide vital fast response and support to other emergency services. Being able to operate in shallow water and high surf zones, Jet Skis are vital to saving lives and deploying first responders.

Over the past five years there have been well documented cases of EGSLSC Emergency Response Service providing a pivotal role in rescues. These cases outline the extreme conditions and long hours the volunteers work under. Rescues or recoveries can take weeks to complete and fatigue of volunteers and maintenance of equipment is an aspect that can impact the service.

The Redevelopment of the Esperance Bay Marina provides a vital piece of infrastructure to assist our services. Floating Jet Ski ramps will provide fast "slide up" docking of our jet skis. Fuel and personnel changes can be conducted seamlessly and improve our on water time. In the past, while conducting a response, a beach / trailer recovery in non-optimal weather conditions is problematic, high risk and time consuming.

We again confirm our support for this redevelopment and please contact the undersigned if you wish to discuss this letter.
